

# FREQUENTLY ASKED QUESTIONS

#### WHAT IS "FOR THE ONE CAPITAL CAMPAIGN?"

"For the One Capital Campaign" is a Gospel-centered spiritual journey that will call us to give more sacrificially than ever before to advance our vision of reaching every man, woman and child with repeated opportunities to hear and respond to the good news of Jesus. The "For the One Capital Campaign" will allow us to purchase 20 acres of land and take advantage of the unique position and future opportunities God has in store for Renovation.

#### WHAT IS OUR FINANCIAL GIVING GOAL?

Our goal is to raise \$1.8 million over the next 36 months that will be over and above our regular giving. This will enable us to pay for the land.

#### WHAT DID THE VISION BUILDER'S OFFERING GO TO?

Our 2019 Vision Builder's offering is being used to ensure that the proposed property will meet and facilitate our future needs.

#### HOW MUCH SHOULD I GIVE?

That's between you and God. The point of "For the One Capital Campaign" is not equal gifts, but equal sacrifice. So, when you seek the Lord as to how much to give, go prayerfully in terms of sacrifice, not just in terms of amount.

# HOW DO I DECIDE HOW MUCH TO GIVE?

The best way to determine how much to give is to attend church and fully engage in the "For the One" Sermon Series, immerse yourself in the "For the One Spiritual Journey Guide" and participate in any of the planned "For the One Capital Campaign" events. After taking time each day to pray and study scripture, we believe you will decide on a sacrificial gift that is fully honoring to God.

2 Corinthians 9:7 Each Man should give what he has decided in his heart to give, not reluctantly or under compulsion, for God loves cheerful giver.

# SHOULD I DIRECT MY REGULAR GIVING (TITHE) TO "FOR THE ONE CAPITAL CAMPAIGN" WHEN IT BEGINS?

No, your "For the One" gift or offering should be above and beyond your regular giving or tithe. Take time to prayerfully consider what offering God is asking you to give.

Malachi 3:10 Bring the whole tithe into the storehouse, that there may be food in my house. Test me in this says the Lord Almighty, and see if I will not throw open the floodgates of heaven and pour out so much blessing that you will not have room enough for it. (this is the only scripture where we are told to test God in this subject).

Luke 6:38 Give, and it will be given to you. A good measure, pressed down, shaken together and running over, will be poured into your lap. For with the measure you use, it will be measured to you.

## SHOULD I PARTICIPATE IF I'M NEW TO RENOVATION?

We are prayerful that everyone will participate. If giving is part of spiritual growth, we want you to grow. You can think of it

another way too: in the same way, someone sacrificed so we could create a seat for you, we want you to experience the joy of creating space "For the One".

#### WHAT IF I DON'T HAVE THE RESOURCES TO GIVE?

It's not the size of the gift, it's the size of the sacrifice. In fact, sometimes those with little bring the greatest gifts of all because it represents a very deep personal sacrifice. God sees what you bring far more clearly than anyone else does.

Luke 21:1-4 As he looked up, Jesus saw the rich putting their gifts into the temple treasury. He also saw a poor widow put in two very small copper coins. "I tell you the truth", he said, "this poor widow has put in more than all the others. All these people gave their gifts out of their wealth; but she out of her poverty put in all she had to live on."

#### CAN I GIVE NON-CASH GIFTS?
